- (3) To vote for any candidate for a TOWNSHIP ADVISORY BOARD, you must make another voting mark for each candidate you wish to vote for. Your straight party vote will not count as a vote for any candidate for that office.

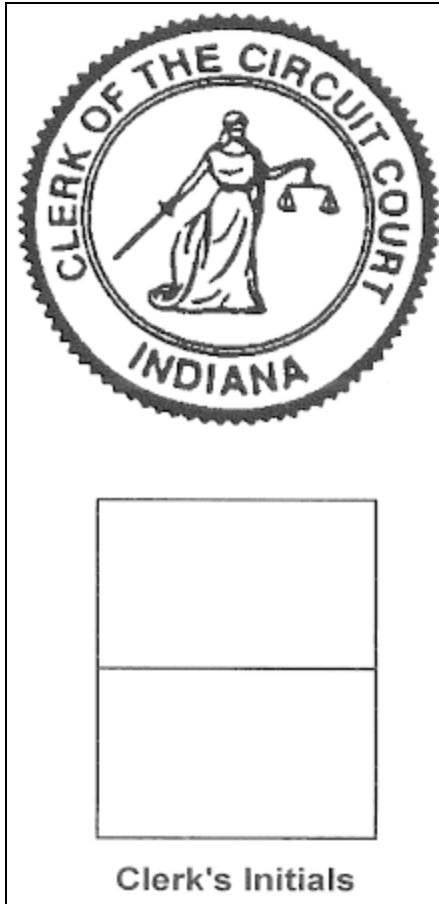
