(2) To vote a straight Republican, Democratic, or Libertarian ticket for all Republican, Democratic, or Libertarian candidates on this ballot, except for candidates described in (3) below, make a voting mark on or in this box and do not make any other marks on this ballot.


(3) To vote for any candidate for a TOWNSHIP ADVISORY BOARD, you must make another voting mark for each candidate you wish to vote for. Your straight party vote will not count as a vote for any candidate for that office.

(4) If you wish to vote for a candidate seeking a nonpartisan office or on a public question, you must make another voting mark on the appropriate place on this ballot.

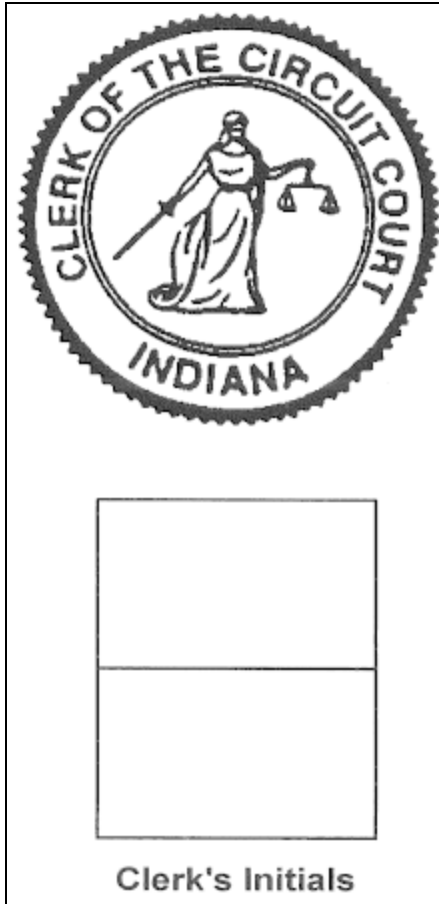
